ASSUMPTION OF RISKS and RELEASE

In consideration of being accepted as a participant in the Loop Road Ski on March 18, 2006, organized by the Wyoming Outdoor Council, **I agree and acknowledge as follows:**

I understand that the event involves certain inherent dangers and risks, including but not limited to those associated with being in the outdoors in Wyoming, in winter and/or skiing. These dangers and risks include but are not limited to: falling and injury while skiing, another skier colliding with you, hypothermia, cold, snowy and/or windy conditions that occur suddenly and include blizzard conditions of driving snow and below 0 degree Fahrenheit temperatures, getting lost, speeding snowmobiles and fatigue. I recognize that medical care may be unavailable or limited during and after the event.

I am aware that injury, death, and/or property damage is possible due to such dangers and risks.

I am fit, healthy and skilled enough to undertake this activity.

I agree that I assume all responsibility for and all risk of damage or injury that may occur to me or my equipment while participating in or arising out of the Loop Road Ski on March 18, 2006.

I hereby irrevocably and forever release, discharge and hold harmless the Wyoming Outdoor Council, its employees, its board of directors, volunteers and agents, and all other associated or sponsoring persons and organizations, and their employees and agents, from any and all legal claims or legal liability of any kind, including negligence, and any and all damages, demands, rights, or causes of action, present or future, whether known, anticipated or unanticipated, including claims for any harm, bodily injury, death or property damage, in any way resulting from or incident to my participation in the event.

If any part of this agreement is found by a court or other appropriate authority to be invalid, the remainder of the agreement nevertheless will be in full force and effect.

This agreement is governed under the laws of Wyoming. This agreement is entered into voluntarily, after careful consideration, and is binding upon the persons signing below, their heirs, executors, and other family members.
